Unconditional and Irrevocable Waiver of Subrogation

This liability insurance includes an unconditional and irrevocable waiver of any and all rights of subrogation against TEFAF, its affiliates, members of its Executive Committee and Board of Trustees, officers, employees, representatives, and agents (collectively, the "TEFAF Indemnified Parties"). This waiver shall apply to all claims for losses, damages, or liabilities covered by the policy and shall remain in full force and effect irrespective of any circumstances, including the payment of claims by the insurer or any other event.

Claims for incidents on public walkways or during stand construction/dismantling are not covered. Damage to exhibits or exhibition stands is excluded.
